# Seniors can reduce their tax burden by donating to charity through their IRA

If you are 70<sup>1</sup>/<sub>2</sub> or older, you can make qualified charitable distributions (QCDs) from your IRA to your favorite charity, including donations to your church.

The donated IRA assets go directly to the charity, so donors do not report QCDs as taxable income and do not owe any taxes on the QCD, even if they do not itemize deductions. Some donors may also find that QCDs provide greater tax savings than cash donations for which charitable tax deductions are claimed.

The QCD counts toward fulfilling your IRA required minimum distribution.
